#### 1. IRC overview


The IRC Rating System is managed by the IRC Rating Authority (RORC Rating Office & UNCL Centre de Calcul) and further administered by 47 additional rule authorities worldwide, on seven Continents, making it the most widely used Rating System available, with IRC certificates issued in 49 countries.

## IRC Numbers

The RORC Rating Office has rated 3111 boats (new applications, revalidations, single event ratings (SERs)) to the end of August an increase of 3.4% (101 boats) over the end of August 2016. UNCL rated 1651 boats 2.5% (42 boats) lower than end of August 2016.

Joint figures show that at the end of August the overall total boats rated is 4702 which is virtually equal to the end of August 2016.


Since 2012 we have seen a reduction each year in total IRC rated boats, but 2017 is the first year since 2012 that we have seen numbers level out with a very similar number of rated boats compared to 2016. The highly successful 2017 Fastnet is an influencing factor on these encouraging numbers.



## **►** MyIRC Development

The RORC Rating Office has successfully continued use of the MyIRC online application portal, and with periodic updates and improvements it is proving to be an efficient tool for GBR owners to submit their IRC applications. The system has also helped to streamline the administration within the RORC RatingOffice.

MyIRC is being further developed to investigate use by Rule Authorities in other





countries. RORC is working with a nation to test how this could best work for both owners and Rule Authorities and continues to work towards the unification of IRC application processes throughout the world.

In addition the Rating Office is working with US Sailing to integrate MyIRC into their SAP certification portal and also investigate areas where this integration can be used for other countries with wider application.

#### 2. Events and Classes

The list of events which used IRC as the principal Rating System in 2017 remains long, with all of the offshore classics (apart from the Newport to Bermuda Race, currently) using IRC as the sole rating system or for the principal trophies. National IRC Championships are held in countries around the world, and in 2017 there were two Continental Championships approved by Congress.

Of course amongst the offshore classics and high level racing, thousands of boats race IRC every week in local and club races around the world. The local racers are very important to IRC and our core stakeholders and we should continue to promote and support this area.

## ► IRC European Championship

The IRC European Championship took place in Marseille, France from 5-9 July with 53 boats from 10 countries. This was following on from the successful inaugural IRC European Championship held at Volvo Cork Week in Ireland in July 2016 which had around 40 boats. The 2017 Championship was

organised by UNCL and three Marseille flagship clubs; Centre Nautique et Touristique du Lacydon (CNTL), Société Nautique de Marseille (SNM) and Union Nautique Marseillaise (UNM), the first time they had organised a major international regatta together. There were 5 fleets from IRC0 to IRC4 racing with trophies for each fleet and an overall prize for the European Championship. Guy Claeys' crew from the JPK 10.10 Expresso 2 were crowned the 2017 Marseille IRC European Champions. In



2018 the IRC European Championship will be in June in Cowes, UK, organised by RORC and incorporating the RORC Commodores' Cup. The Championship in 2019 is scheduled for the Netherlands and is likely to return to Ireland for the Royal Cork Yacht Club's 300th anniversary in 2020.

## ► IRC North American Championship

The Storm Trysail Club's Block Island Race Week hosted the 2017 North American Championship for three IRC divisions. The overall Championship winner was TP 52 Spookie (Steve & Heidi Benjamin).

## ▶ The Maxi Yacht Rolex Cup

One prestigious event for IRC is the Maxi Yacht Rolex Cup, incorporating the Rolex Maxi 72 World Championships, held in Porto Cervo in September The event is organised by the Yacht Club Costa Smeralda in collaboration with the IMA (International Maxi Association). At the 2017 event, out of



an entry of 61 boats, 56 competed in IRC Classes: Maxi Racer & Supermaxi, Maxi Racer/Cruiser, Mini Maxi Wally and the Maxi 72 Class.

### ► Fast 40+

The Fast 40+ class enjoyed close and high level racing this year, . racing on IRC corrected time but under tight class limits. 12 boats competed at the One Ton Cup in Hamble, UK and the class continues to grow. We hope it will also expand outside the UK.

# ► Offshore Sailing World Championships 2018

In 2018 the Offshore Sailing World Championships will take place in the Hague, Netherlands, from 12 to 20 July. A world championship was awarded to IRC at the World Sailing annual meeting in 2016 on the proviso it is a combined scoring event with the ORC World Championships. Each boat must have a valid ORC International certificate and a valid IRC Endorsed certificate. There will be 3 Classes based on ORC fleet



splits with an ORC Class Division Length (CDL) range 8.45<CDL<=17.0. For more information and the Notice of Race see offshoresailingworlds2018.com.

## 2. Technical developments for 2018

The IRC Technical Committee met in Southampton on 6 September. Rule changes were agreed to present to the IRC Congress in November and a good number of rating calculation development were discussed:

## Rule Changes

These include simplification of mainsail width rule, removal of dayboat classification from the rule, sail measurement methods, hull factor definition, advertising rule and lifting foil definitions. Rule changes and explanations are presented in the "Proposed IRC Rule Changes for 2018" documentation.

# Rating Changes for 2018

 The treatment of lifting foils and lateral foils for increasing dynamic lift (such as DSS) was considered. Simple rules definitions have been developed (presented in rule changes) to describe the foil shape. IRC will therefore recognise the effects of these foils in a more realistic manner while continuing to encourage designers to learn and evolve the systems.



Whilst we have reduced the impact of Forestay Length - FL such that it will no longer cause a
noticeable change to rating, the IRC Technical Committee has decided that it should remain
a measured parameter in the database, in case of unforeseen consequences that cause us to
reinstate it.



- We continued to monitor the effectiveness of the fin ballast rating with the intention that complex keel fin structures should not be encouraged. We conclude that the current TCC impact does not need further adjustment at this time.
- Some ratings have either increased or reduced due to a change in the method used to rate spinnaker area, this is change that has been applied across the complete IRC Fleet and is being phased in over 4 years. The final year of this change will be 2018.

# Rating Changes Beyond 2018 and for Further Consideration

Crew number options were debated, with a paper sent to the IRC Policy Steering Group to consider crew number options within the IRC Rating TCC. Other considerations included Gennakers and CodeOs and the development of IRC to better rate these types of sails, particularly when they are used in a windward application on large fast boats. Other areas that have been under development include the beam effects and the windage of the hull superstructure


## 4. Measurement and Rule Authorities.

We continue to work with World Sailing in trying to expand the use of IHC for sail measurement around the world, and the work on the UMS with the ORC and US Sailing continues and is becoming more important with our cooperation over the IRC/ORC World Championships in 2018.

### 5. Fleet statistics

So as to provide more suitable statistics for comparative purposes we have included the total number of certificates issued as well as the number of boats rated for each of the last 5 years in a table below. From this we can see that the predicted number of certificates for 2017 is in the region of 7,300 worldwide, to approximately 5,300 boats.
